You can use this template to prepare your abstract off-line and copy-and-paste the plain text into the Abstract Submission Form. We recommend that the abstract is carefully compiled and thoroughly checked before submission, in particular with regard to the list of authors. For abstract submission the following fields must be filled in:

First field – Title (capital letters);

Second field – Surname and Name initial(s) of author(s). Multiple authors must be separated by a comma (the last author is preceded by "&") and marked by a superscript number related to their affiliations. An asterisk must be added as a superscript to the name of Corresponding Author.

Third field – Affiliation(s). Affiliation should be given as Department, Institution, Country. Affiliation address is not required. Please spell out the acronyms, e.g. "Consiglio Nazionale delle Ricerche" instead of "C.N.R.";

Fourth field – Preferred session(s) and presentation type (oral or poster) to be selected through the drop-down menu;

Fifth field – Keywords (up to 3 keywords).

Next field is for the Abstract body text. It should be short (maximum of 3000 characters including spaces), concise and clearly written in English language with correct spelling and style. Abstracts must be composed of text only. Figures and tables must not be included. It is not allowed to use footnotes.

Mathematical symbols and equations must be typed in, and metric symbols should be used. The mathematical formulas, if not recognized by the system, will be sent by e-mail as an image file (.jpg).

Please note that the copy-and-paste from a word processor file must be carefully checked. Formatting commands like super- and subscripts, special characters, etc. might not be correctly pasted and LaTeX commands need to be directly inserted in the form.

Bibliographic citations in the text (included in the 3000 characters) should be indicated in parentheses: author's last name, comma, year of publication. Multiple citations must be entered in chronological order and separated by a semicolon (Brindley & Robinson, 1947; Guinier, 1956; Halbach & Chatterjee, 1982; Conticelli et al., 1992).

"Accepted" or "in press" manuscripts can be cited in the text provided that it is clearly indicate name and volume of the journals. Ph.D. or Dissertation Thesis can also be cited in the text. Citations are not allowed for manuscripts "submitted" or "in preparation".

References should be listed alphabetically at the end of the abstract (not counted within the limit of 3000 characters), as follows.
